Pedestrian Fatalities Up 100% in Washoe County

Reno, Nevada (August 27, 2019) – Pedestrian fatalities are up 100% countywide between January 1 – July 31, 2019, according to data from the State of Nevada's July Fatality Report. There were four pedestrian fatalities in Washoe County last year between January 1 – July 31, 2018. So far in 2019 for this same time period, there have already been eight pedestrian fatalities.

Recent pedestrian crashes in northern Nevada are a growing trend here in our community. Pedestrian fatalities in Washoe County account for 36% of overall vehicle crash fatalities this year between January 1 – July 31, which is more than twice the national percentage of pedestrian fatalities in 2018, which was 15%.

The Vision Zero Truckee Meadows task force would like to remind the community to use extra caution on area roadways. Drivers should always be scanning for pedestrians as they drive down the street. Pedestrians have the right-of-way whenever two streets intersect, as well as at marked midblock crosswalks. Even at 30 miles per hour, drivers may not see pedestrians in their field of vision waiting to cross the street without intentionally looking for them. The faster a car travels, the narrower the driver's field of vision is and vehicles require more stopping time and distance.

Pedestrians and drivers should make eye contact with each other and pedestrians should give drivers time to stop for them. During darker conditions, people walking should wear reflective items or lights to make themselves more visible.

The Vision Zero Truckee Meadows task force reminds drivers, pedestrians, bicyclists and all road users to plan ahead and leave a little early to have the time to arrive safely at their destinations.

With recent pedestrian crashes in northern Nevada, these safety tips are useful for everyone. Look left, look right, let's look out for each other.
